Awionetka Awards - Regulations

Art. 1. Organizer

1. The Organizer of „Awionetka” award contest, hereinafter referred to as “the Contest”, is Actia Forum Ltd., with the registered office in Gdynia, ul. Pułaskiego 8, entered into the register of entrepreneurs of the National Court Register kept by the District Court in Gdańsk, 8th division, under number KRS: 0000013138, hereinafter referred to as “the Organizer”.

Art. 4. Entities Entered for the Contest

1. „Awionetka” is an award for recognition in aviation sector, granted to enterprises and natural persons from aviation sector or sectors cooperating therewith. The award is granted for spectacular achievements within the period between August 2009 and August 2010.

Art. 5. Awards

1. Winners receive an „Awionetka” statuette and a diploma certifying recognition in a particular category.

2. Awards are granted by the Organizer, the Chairman of the Committee and/or the Minister of Transport.

1. The term of the Contest shall be from June 15th to Sep 6th 2010.

Art. 8. Sposób Wylaniania Laureatów Winners Selection

1. Stages of the Contest:

1st stage - Candidates proposing from **15th of June till 6th of September 2010**. Providing the Committee with Candidates' list.

2nd stage - By **Sep 13th 2010** the Committee members shall share their choices in particular categories with other members. Committee members shall contact via e-mail.

3rd stage - The Committee Meeting on **Sep 17th 2010** for the purpose of final selection of Laureates (five equal Award Winners).

In the course of the 3rd stage the Committee shall select winners by voting.

2. The Committee shall justify their selection of Award Winners.

3. If, any of the Committee members is in any way related to a proposed candidate, he/she shall be excluded from voting in the category for which the candidate was entered.

4. The results shall be officially announced during a ceremonial Gala on Oct 7th 2010.

Art. 9. Final Provisions

1. Persons voting in the Contest shall agree to apply to these Regulations and to the use of their personal data for purposes related to carrying out the Contest.

2. The Organizer reserves the right to extend or limit the term of the Contest and to change the nominees' list announcement date.

3. The Organizer reserves the right to amend these Regulations in the course of the Contest.
